NOTICE TO THE BAR

Protocol for Non-Jury Trials During the COVID-19 Judicial Emergency

Please take notice that subsequent to **November 2, 2020**, the Court will be scheduling non-jury trials for matters in the Arbitration Appeal and Major Non-Jury programs, including those matters previously listed in the **July and November 2020 Trial Pools**, as well as those matters previously scheduled for trials earlier in 2020, but were postponed due to the coronavirus (COVID-19) judicial emergency. If your trial is on the attached list, all parties must <u>immediately</u> notify the Court in writing of any matters that have settled and file an Order to Settle, Discontinue and End. All parties must <u>immediately</u> notify the Court of any scheduling conflicts, including trial attachments and prepaid vacations. Conflict letters must be electronically filed under the "existing case" section of the Electronic Filing System under the conference submission category. Any requests for continuance must be <u>immediately</u> submitted in writing and made only under exigent circumstances.

Counsel and self-represented parties will be served with a Scheduling Order, attaching counsel/parties for trial for a date-certain.
